I am writing to request all information you currently hold on what powers have been used by the Council under the Health Act 1956 between the 1st of January 2020 and the day you received this email.

I am specifically interested in any documents that relate to the Council's use of powers to enter and inspect any dwelling that they may consider to be unhealthy or a nuisance, and any notice or enforcement made due to the nuisance.

If the Council or its contractors have provided notice that a dwelling required work in order to be habitable I would like all information about such notice. This may include the notice itself, supporting evidence for the notice provided, the outcome of the provided notice, and any legal advice sought or received by the council on said notice.

I would also like to request any legal advice received by Council in regard to the Health Act 1956 during the aforementioned dates.

Hutt City Council has not used any powers under the Health Act 1956 since 1 January 2022, to enter and inspect a dwelling. Subsequently no related notices or enforcements have been made. Further, no legal advice has been received by Hutt City Council with regard to the Health Act 1956 during this period.

Accordingly, your request for this information is refused under section 17(g) of the LGOIMA, on the grounds that the Hutt City Council does not hold the information that you have requested, and we have no grounds to believe that the information is held by, or connected more closely with, any other local authority, department, Minister of the Crown or organisation.
