In response to your not ficat on/comp a nt received Monday, 27 November 2023. My notes included along with some following.

- The consent was granted n 1996 we before the odour canon were n use. When the consent doesn't specificary related to the odour canon, v s b e d scharges should not occur as required in condition 19.
- The odour canon does require consent under our regional rules, it currently is not consented.
- GWRC have previously requested information around public risk and Regional Public Health have responded stating it is not a public health risk. Based on this information we deemed it low risk to a low the continue use of the odour canons in the form of mitigating odour without consent until a consent is odged.
- The comp ance officer has taken this comp a nt to assess next steps for comp ance which to date has included discussions with WWL around the effect veness of the odour canon in mitigating the odour and the best way to use the canon e.g. directly at the known source vs high into the air (to ensure compliance with visible discharges under condition 19) and actions WWL need to take toward obtaining consent for odour canon use.
- Enforcement act on s not be ng pursued for the use of the odour canon.

I wish to ay a formal comp ant about a serious breach to the Resource Consent WGN950162(01) for the Seavlew Wastewater Treatment P ant.

# WGN950162 [1] Contaminants Discharge to Air WWTP (Seaview WWTP)

In the add t ona cond t ons to Resource Consent WGN 950162 (01):

Cond t on 18 states that the opac ty of a  $\,$ d scharges from combust on app  $\,$ cat ons and any s udge  $\,$ dr er (exc ud ng steam) sha  $\,$ not exceed 20%, except for a per od of ten m nutes for start ng up from co d.

Cond t on 19 of the Resource Consent states that "There sha be no v s b e d scharges, exc ud ng water vapour or c ean steam, from any act v ty on the s te, exc ud ng act v t es spec fied n cond t on 18".

However, for several years, the Seaview Wastewater Treatment Plant has used "odour blasters", For examples: "This work may take up to three months to complete and we are running odour blasters during this time to help reduce the odour": <a href="https://www.wellingtonwater.co.nz/about-us/news-and-media/news-and-media-2/seaview-wastewater-treatment-plant-odour-causing-a-stink/">https://www.wellingtonwater.co.nz/about-us/news-and-media/news-and-media-2/seaview-wastewater-treatment-plant-odour-causing-a-stink/</a>.

However, as you can see in the attched video footage of the odour blasters, which are located within the Seaview Wastewater Treatment Plant, the odour blasters emit a plume of clearly visible spray, which we have been advised is a chemical called Hi Chem Disinfectant Reodorant (quarternary ammonium compounds, alkylbenzyldimethyl chloride.

This clearly breaches conditions 18 and 19 of the Resource Consent WGN 950162(01).

We would like to register this complaint formally, and be notified of the GWRC penality for this infringement, and to ensure that this ceases immediately.

This morning we discussed the Seaview Treatment P ant at length at the Shared Services Committee. And I asked the questioned you raised below to our officers.

Regard ng the current maintenance work, I want to assure you that while this work primarily focuses on upkeep, it is a step towards improving the overal functioning of the plant. This maintenance is part of a broader strategy to address the issues you we ment oned. It is crucial to maintain and improve the existing infrastructure as we plan for more significant upgrades. It wighter that greatly improve the odour issued we've had recently once complete early next year.

I'd ke to update you on the p ant's upgrade s tuat on. Whee we haven't secured funding yet, there s an important development to note. This Monday, a council paper with be presented to consider when improvements to the plant could be made. It is operating as designed currently, but we acknow edge the need to reduce the odour impacts. The est mated cost for these improvements is about \$13 miles on, earmarked for 2026-2028 in the current plans (you can see these on our website on the papers for Mondays meeting on page 129<<a href="http://infocouncil.huttc.ty.govt.nz/RedirectToDoc.aspx?">http://infocouncil.huttc.ty.govt.nz/RedirectToDoc.aspx?</a>
<a href="https://infocouncil.huttc.ty.govt.nz/RedirectToDoc.aspx?">URL=Open/2023/11/LTPAP 27112023 AGN 3176 AT.PDF></a>). However, the council could decide to bring this time in eforward. It is a challenging decision, especially in these financially difficult times, with rates a ready projected to increase by about 15-20%. Rest assured, we are weighing a lopt ons carefully.

Thank you for reach ng out and shar ng your concerns about the odour from the Seav ew Treatment P ant. I complete y understand the distress and frustration this situation is causing you, especially as it impacts the enjoyment of your property and community spaces.

P ease be assured that We ngton Water and Hutt C ty Counc are act ve y address ng this issue. The current strong odours are a result of essent a maintenance work at the plant, specifically the replacement of the bloff terimed a, which is crucial for reducing odour levels ong term. While these works are necessary, we recognise the significant inconvenience they have caused.

We are work ng d gent y to complete these works as quickly and efficiently as possible. However, due to the nature of the task, nterm ttent periods of stronger odour are unfortunately unavoidable. The team at Weilington Water is employing odour blasters during the process to min mise the impact as much as possible. The entire replacement process is expected to last three

months, with the strongest odours like y to occur on y during short intervals.

This means that both Cells are now operational and treating the odorous gases as designed. (Image 1)

Next week Cell 3 will be excavated, and inspections will be performed before installing the new media.

The replacement media for Cell 2 will be delivered this week and the team are optimistic of installing this ahead of schedule to fully commission cells 1 & 2 next week.




Image 1 - New media installed into Cell 1.

To Councillors,

I would like to make some comments on the above for the meeting to be held on Monday 27th November 2023.

The HCC and its ratepayers are facing a difficult time with a number of economic issues facing them and so I offer my observations for your consideration.

## These are;

- A LTP is a requirement of legislation and is in fact a waste of time as it can be altered (and is) every time it is revisited-this is for genuine reasons (inflation/change of Government etc etc.)

The key in my view is the next 5 years which can set out the general direction of the Council.

-One of the key principals is **Affordability of rates** and an **AVERAGE of 20.7%** will not be acceptable by ratepayers in spite of the Financial Hardship Remission being increased. Insurance costs are also increasing

significantly and so I suspect that this will either drive people out of the area or people will

not insure-this is not good for HCC.

- -There are still a lot of "nice to haves" in the LTP and this is illustrated by the rates increased predicted for the next 3 years-20.7% in year 1 and then less than double digits in the following year.
- -These "nice to have" appear to include councillors hobby horses and other "requirements" which are not essential at this stage.
- -There are also many 'unknowns " included in the LTP including
- -No contribution from incoming Government as a result of the proposed change in the 3 Waters model that the previous Government had proposed.
- -Riverlink which already appears to show signs of significant cost increases and possible delays.
  - -Contract renewals and their impact on cost increases.
  - Waka Kotahi funding for a number of the projects is questionable at this stage.

All these factors clearly show that the borrowing ceiling is likely to be exceeded-probably earlier than forecast.

As a result of Climate Change is the Hutt Valley likely to see another Eastern Hutt road slip or perhaps some severely affected locations (Sea rise, flooding )which are rendered uninhabitable (Level 3 land red stickered)?

While not suggesting these be included in the LTP, any prudent person would allow some more borrowing headroom to accommodate these and other factors (Inflation, High Interest rates, supply chain

issues, resources availability etc etc)c. HCC does have a Climate emergency. Also Insurance companies have a view that the Wellington area is very vulnerable to natural disasters

including earthquakes and sea level rises. I don't see this in the current LTP but HCC needs the capacity to borrow to meet some of these costs.

Also UPL appears to be pushing out the repayment of its Loans and this in turn will impact on the borrowing capacity of the HCC.

So what are the solutions?

- -Do NOT start any new major projects until there is some better certainty in the cost of existing projects.
- -Reschedule some of the earlier projects. This includes 3 Waters where there is significant expenditure provided for with new reservoirs(increased demand?),wastewater and storm water

in the next 3 years. Why so much increases in expenditure in such a short time frame.

- -more user pays approach-eg Silverstream cost increases and capital expenditure, Fees etc.
- -Is the capital expenditure programme with Wellington Water value for money (overdesigned?) and can Wellington Water deliver the projects for HCC as indicated. Wellington Water have 3 other

local Councils that they have to provide resources for and meet there work requirements. This workload is likely to be increased (Kapiti Plus Wairapapa Councils) if the new

Government gets its way.

I refer to some of the Wellington Water comments in their submission to HCC (their April 2023) and which was included in the HCC October papers.

- -Increase Reserves Investment Strategy-I raised the question of the increasing levels at the last LTP review and I see that this is now being addressed. I would question why it is not utilised more.
- -Push the sale of commercial businesses operated by HCC while retaining the land/rights etc. This is Seaview Marina and UPL, UPL appears to be struggling to find any major projects and both Housing Corp and Developers are

there to fill any gaps in the rate of development of new housing. The extension of the UPL loans(and lesser extent Seaview Marina) is suppressing the opportunity for HCC to utilise these borrowed funds?

One option for the HCC is to suspend the presentation of the LTP beyond June 2024 deadline. This is because there are so many variables which I have mentioned above which are dependent on the incoming Government.

There is already 1 Local Council that has taken this approach.

These are some thoughts which may trigger some further options to reduce the level of Rate increases that is being publically aired.

# <u>Seaview Wastewater Treatment Plant Odour Update following the community meeting on 6</u> <u>December</u>

Around 80 people attended the Wellington Water and Hutt City Council hosted public meeting on Wednesday evening to discuss what Council and Wellington Water are planning to address the odour issue at the Seaview wastewater treatment plant.

Te Rūnanganui o Te Āti Awa ki te Upoko o Te Ika a Māui, Waiwhetu marae and Wellington Tenths Trust/Palmerston North Māori Reserve Trust were in attendance as were many residents. Apart from the Hutt Park Holiday Village (Top 10), there did not appear to be other business representatives there. Deputy Mayor Lewis, Councillors Edwards, Brown, Dyer and Mike Fisher Petone Community Board Chair also attended. Senior HCC and WW staff attended as did GWRC staff.

The presentation from Wellington Water (on link below) appeared to answer many questions and concerns, with assurances given by Council that we will do all we can to address the odour issue in the short and medium term.

There is still an underlying frustration, particularly from residents, with the time it is taking to address the issue and, in the meantime, having to live with the offensive smell.

Hutt Park Holiday Village was critical of the timing of the biofilter works during their busiest period, noting it had received poor reviews of late due to the smell. Wellington Water expects this work will be completed by 25 January and there will be a significant improvement re the odour from then.

Actions that have or will be undertaken as a result of the feedback from the meeting.

- 1. Regular (fortnightly) updates given on the biofilter works.
- 2. The presentation and FAQs are on the Wellington Water website <u>here</u>.
- 3. Information sheet on the project prepared for the Hutt Park Holiday Village to distribute to its customers as required. A staff member will be the key contact for the Top 10.
- 4. Local signage advising of biofilter works erected.
- 5. Direct contact made with Mana Whenua to discuss associated wastewater issues, specifically the overflow into Waiwhetu Stream which was raised during the meeting. An update on Wellington Water will be added to each quarterly hui with Mana Whenua.

Please also see attached update received today on the commissioning of Cells 1 & 2.

#### Good afternoon councillors

I have read in the Post about the issues with the outfall pipe from the wastewater plant in Seaview to Pencarrow, and the options of relining the existing pipe or replacing it (article here <u>The Post</u>

The Post

). It is unfortunate that this huge cost/issue should arise, but we will not fix our city and its issues by ignoring them or engaging in magical thinking.

I am strongly in favour of replacing the existing pipe to accommodate future population growth, instead of relining the existing pipe. It is of utmost importance that the Council understand that the era of slow population growth Hutt City experienced prior to around 2010 is over and that thanks in large part due to surging property prices in Wellington City causing many people to seek housing in the Hutt Valley, and surging migration into New Zealand (it could reach 100,000 people net per year) our city's population is growing fast now and could grow by around 2% per annum. This would see around 50% growth of 55,000 people over the next 20-25 years. We need to accept this reality (I see it as a positive) and ensure that we have the infrastructure needs to support a larger and growing population. Too many councils in the past have neglected the need to support population growth, preventing housing developments which are needed from being built, leading to skyrocketing house and rent prices and all sorts of ills. We should not repeat their mistakes

I know the cost may require large rate increases which nobody likes, but if we fail to address the future needs of the city we will all be poorer off in the longer term for it.

The strong odours from Seaview Treatment plant have been raised as a concern by some residents and the Waiwhetu Marae over the weekend.

As you will be aware, Wellington Water is replacing the biofilter media at the plant, which once installed are expected to improve odour levels. Wellington Water are working closely with the plant operator and contractor to ensure the work is done as quickly and safely as possible. The deodorizer is working and will be used throughout the works.

This work was programmed to be done before the end of the year. Given the nature of the work, there is no ideal time. Whether the works are in summer or winter, stronger odour levels at times, are unfortunately unavoidable.

While the odour levels are particularly strong and unpleasant, the community can be reassured that there are no associated public health risks and that due process is being followed with the maintenance works at the treatment plant.
